KPMG Caspian Region (hereinafter "KPMG") hereby expresses its respect and gratitude to you and appeals for the support of domestic producers of goods and service providers who would like to export the outputs of their activities to the United Arab Emirates.

The United Arab Emirates is a strategic partner for Kazakhstan and over the years of bilateral cooperation, both countries have achieved high results through trade and economic relations, and mutual support. During the telephone conversation between Prime Minister Mr. Alikhan Smailov and Deputy Prime Minister, UAE Minister of Presidential Affairs Sheikh Mansour bin Zayed Al Nahyan, intentions were expressed to continue and strengthen cooperation between our countries.

As far as you know, the Ministry of Trade and Integration of the Republic of Kazakhstan, together with the operator of non-financial measures to support non-commodity exports, JSC "Center for the Development of Trade Policy "QazTrade" (hereinafter "QazTrade"), is implementing the "Export Acceleration" Program (hereinafter the "Program"), which has been successfully continuing since 2020.

In 2022, the operator of the Program selected 190 participating companies from such industries as OEM, light, chemical and food industries, as well as from the service sector to participate in the Program in 2022.
