
ECMAN was founded in 1983 in the State of Bahia and, besides Brazil, we are present in 08 (eight) countries in South America, Central America and Africa.







Capital Structure

ECMAN's subscribed and paid-in capital in financial resources was changed on **June 1, 2022**, from **US\$ 5 million** to a total of **US\$ 20 million**, subscribed and paid in financial resources from the controlling company of ECMAN's shares, TIUÁ EMPREENDIMENTOS LTDA. TIUÁ has 100% of its shares controlled by Luciano de Carvalho.

This increase in Capital resources of USD 15 million went to basically two different uses:

- ➔ Acquisition of new equipment such as: cranes between 150 and 300 tons, earthmoving equipment, trucks, and special field tooling.
- ➔ Working capital to finance the operations and to provide the company with a greater capacity to negotiate with suppliers that represent a large volume of purchases in the works.

Insurance and Surety

With the new Capital Structure, our insurers partners, Tokyo Marine, Zurich, Porto Seguro and Potencial Seguros, increased our coverage limits to a total limits of issuing advance customer and engineering insurance to a new total of **US\$ 42 millions**, which represents **US\$ 250 millions** in new construction contracts. It's important to emphasize that ECMAN has never had a single insurance claim of this type.

TECHNICAL STRENGTHS

In its history, **ECMAN** has accumulated about **500 certifications** of works delivered and approved in Brazil and other countries. They are industrial and infrastructure projects.

In sanitation network works and in constructions of drinking and waste water treatment plants we executed projects and works estimated in about **US\$ 342 million**.

In road and highway construction we executed works estimated to be worth around **US\$ 640 million dollars**. Thus, the company has built, rehabilitated, and performed maintenance on 3,521 kilometers of roads.

Regarding the construction of industrial units, we have already executed projects worth around **US\$ 980 million**.



Comercial Strenghts

In the infrastructure, oil & gas and industry sectors, throughout its history **ECMAN** has participated in projects with a total value of **US\$ 3.4 billion** in Brazil, South America, Central America and Africa.

ECMAN has about **US\$ 205 million** of contracts in portfolio (works in progress) in the countries where it's present.
