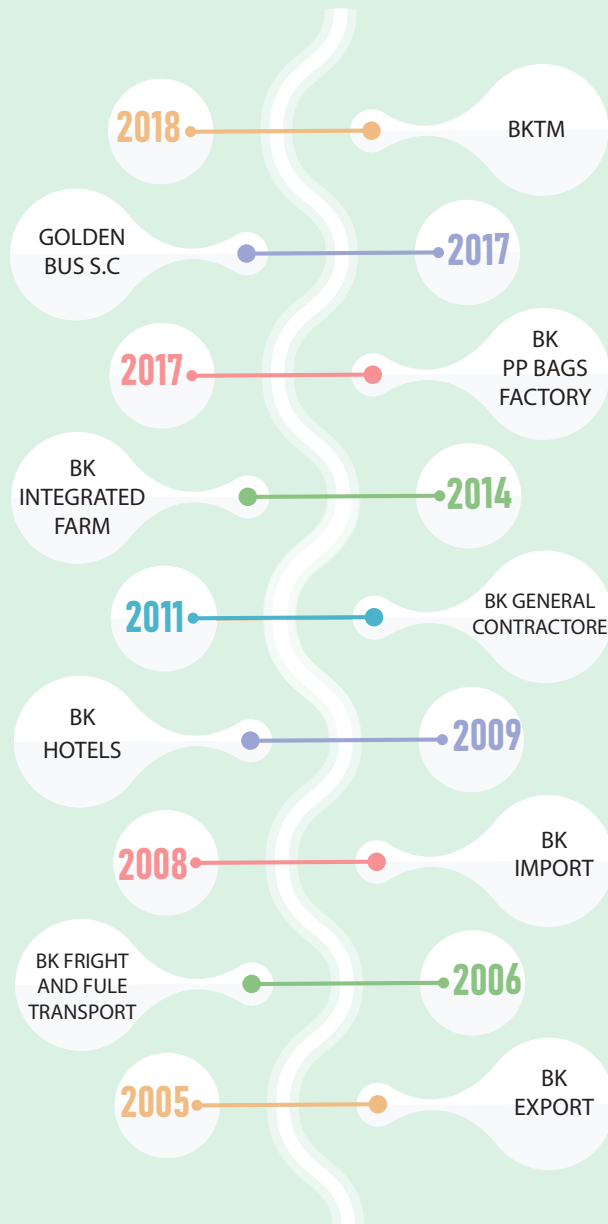

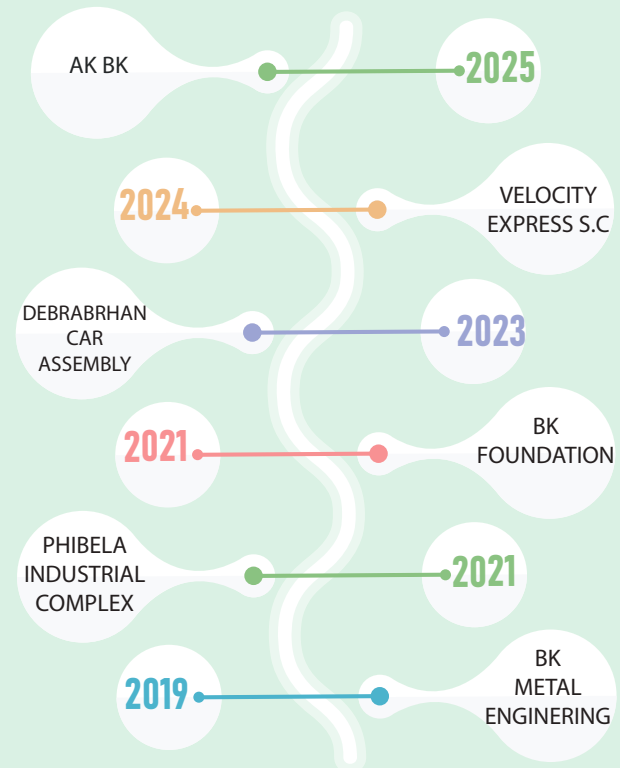

Additionally, BK Metal Engineering Complex and Debre Birhan Car Assembly Plant are remarkable achievements that reflect our dedication and hard work.

In the next coming years, we will focus on expanding the scale of our commercial farms. Additionally, to support the government's economic goals of import substitution and promoting the export of

value-added products, we are working on installing a protein powder processing facility.

The crushing plant is located in a compound where PhiBela Industrial PLC is situated. Our investments are currently focused on three mega projects: the redevelopment of a high-rise luxury Ethiopia hotel and apartment complex in Addis Ababa, the Piassa real estate and apartment building project, and the five-star Bahir Dar Hilton Hotel and Spa project.

The outstanding leadership role of the Board of Directors at the BKG in collaboration with the management team and employees of our companies has played a pivotal role in the success of our mega projects and the realization of the five-year strategic plan. Finally, I would like to express my gratitude for the unwavering support and dedication of the BKG business community in building a robust private investment institution. GENERAL BACKGROUND OF BKG

Mr. Belayneh Kindie began his business 33 years ago with a start-up capital of ETB 4,600 as a small-scale trader of butter and honey between the countryside and Addis Ababa. He also used to supply consumable commodities to rural households. In 2000, he began wholesaling and distributing of honey and butter. In 2002 he partnered with other two friends to supply oilseeds to export. In 2005 M.r Belayneh established Belayneh Kindie Import Export as a sole proprietorship in and became a market leader in oilseeds export in the country. He has been certified by the Ethiopian Commodity Exchange (ECX) for standing first among the exporters of sesame seeds in 2018.

In 2020 M.r Belayneh realized the present-day business conglomerate called Belayneh Kindie Group (BKG), comprising 23 companies and more than 7,000 employees.

BKC, one of the business institutions operates across a variety of sectors. It oversees more than 4000 employees and manages 16 companies which are engaged in International Trade, Manufacturing, Construction, Agriculture, Hotel Service, Public and Cargo Transport Services, Real Estate and Mining.



1. INTERNATIONAL TRADE

The foundation of BKC's companies was built on Mr. Belayneh's investment in international trade. The import and export sector has contributed

significantly by generating foreign currency and importing manufactured goods from global markets

Export Business

BKG includes an affiliate import-export company that was established in 2005. With an investment capital of ETB 3 million. The company is



widely recognized as one of Ethiopia's most successful businesses. It specializes in exporting agricultural commodities especially, sesame seeds, pulses, and coffee. The export department is a market leader in the export of sesame oil seeds. The export department generated more than 700 million USD in the last 20 years.

Import Trade

After a successful performance of the export business to Mr. Belayneh Kindie added an import business in 2008.



The company imports different types of products such as steel bars, tires for its transport companies, paper, and CKD products for its vehicle assembly plants, and spare parts for vehicles and also different types of vehicles.

2. INTEGRATED AGRICULTURE SECTOR

Agriculture is one of the sectors in which Belayneh Kindie Group (BKG) is engaged. This sector began started farming in 2014 and today BKG has 5 farms with over 20 thousand hectares of land. Cereal, Oil and pulse crops, coffee and spices, vegetables and fruits are the main crops cultivated in the farms. The

BK Yirt Valley Farm

The farm commenced operation in 2014 by starting with 2,700 hectares of arable land in the South Western Ethiopia Region, west Omo Zone. This commercial farm specializes in exportable agricultural products such as coffee, sesame seed, sunflower, soybean and cereal crops. The Regional Government has recognized the farm to be seen as a model farm in the region.

farms are not concentrated only in crop production activities, but livestock and honey bee farming are also the core activities in the farms. Therefore, The main purpose of expanding the agricultural sector is for food and nutritional security, import substitution by oil crop production as a raw material for Phibela and other oil factories and enabling the country to earn more foreign currency by adding value to the oilseeds, coffee and pulse crops to be exported.



BK Abaya Zuria Horticultural Farm

The farm located in the Sidama Region was secured in October 2022. BK acquired 550 hectares of land from the regional government to produce exportable fruits such as papaya, avocados, bananas, and oranges. Currently, the farm has started marketing bananas and papayas.



BK Enormena Commercial Farm

This farm is located in the Central Ethiopia Region, Ghurage Zone. BK acquired 5,000 hectares of land from the regional government in 2022 to produce sunflower, soybean, sesame, and cereal crops as well as livestock's and honeybee. This farm is 50

km far from Wolkite Town and 180 km from Addis Ababa. Since the farm surrounded by two rivers, it is planned to include the coffee, fruit and vegetable farming under irrigation and animal husbandry together with poultry farming.



BK Mashinga integrated Farm

The farm is located in the Southern Ethiopia Region.

BK secured 1050 hectares of land from the regional government to produce cereal, pulse and oil crops (sunflower, soybeans, sesame, haricot bean and mug bean), Livestock rearing and fattening.



The farm also includes honeybee production as part of its activities. Given its proximity to regional cities and Addis Ababa plans are underway to launch fruit and vegetable farming on the premises using irrigation.



PhiBela Guba Farm

The farm began operations in 2020 with 7,000 hectares of arable land acquired from the Benishangul Gumuz National Regional State. This new commercial farm is located in the Guba area. In the initial phase of its establishment, road and housing infrastructure developments have taken place. It has also begun producing sesame and other seeds which PhiBela Industrial Complex uses as a raw material for edible oil production.



3. BKG'S MANUFACTURING SECTOR

The manufacturing sector is the major investment area of BKG. The manufacturing sector comprises four companies namely PhiBela Industrial PLC, BK Metal Engineering Complex, PhiBela Debrebirhan Car Assembly, and BK PP Bags Factory.





PHIBELA INDUSTRIAL PLC

PhiBela is a huge edible oil refinery not only in Ethiopia but also in Africa.

The investment capital of the Phibela Industrial Complex was 4.6 Billion ETB. The Industrial Complex is also equipped with modern machinery capable of producing high-quality edible oil from different types of oil seeds.

After assessing the country's edible oil market by conducting a feasibility study the realization of establishing a huge edible oil factory started in 2021 at Bure town, Amahara region which apart 441 km north of Addis Ababa.

This industrial complex rests on 30 hectares of land. When it becomes fully operational, it can produce 60% of the edible oil demand for the Ethiopian market. It can also save 30 percent of foreign currency expenditure.

PhiBela's Products and Services

Quality

Phibela is working to be one of the best agricultural products processing plants in Africa, especially in the supply of quality value-added sesame seeds products supply for the global market. To realize this objective we have obtained ISO certificates.

These certificates make PhiBela the first agro-products processing industry in Ethiopia that possess three certificates at the same time.

Factories Operating in the Phibela Industrial PLC:

1. Edible Oil Refinery and Fractionation Plant

This edible oil factory has a Refined, Bleached, and Deodorized (RBD) Palm Fractionation Plant and a Refined, Bleached, and Deodorized (RBD) Soybean and Sunflower Refinery Plant. The crude soybean and crude sunflower oils are refined using a chemical refining process that involves degumming for the removal of phospholipids, neutralization for



the removal of FFA, and bleaching for decolorization and deodorization. Because the hydrated content of imported soybean oil would be degummed,

only the remaining non-hydratable gums will be removed using phosphoric or citric acid in the Phibela refinery plant.



The capacity of the RBD Palm Fractionation Plant is more than 800 tons/day and produces high-quality palm oil mainly CP6 and CP8 and palm stearin which is an input for margarine and shortening industries and soap industries. The RBD Soybean and Sunflower Refinery Plant is equipped with more than 600 tons/day capacity of the deodorized plant that can produce high-quality RBD Soybean and Sunflower edible oil from crude soybean and sunflower oil.



2. Filling and Labeling Lines Plant

There are 10 lines with 8-12 filling heads with automatic capping, aluminum foil sealing, box filler, and case sealer for low-volume plastic bottles, with a filling capacity of more than 1.6 million liters per day.



3. Bottling Factory

This factory produces plastic bottles including Jeri cans. The main sources of raw materials for the production of packaging materials for finished edible oils are PET and HDPE. PET (Polyethylene Terephthalate)



plants can produce up to 650 tons/day of different sizes of PET bottles such as 1L, 2L, 3L, 5L, 20L, and 25L with a holding capacity of up to 1.2 million liters of edible oil per day. HDPE (High-Density Polyethylene) Processing plants can produce up to 800 tons/day of different sizes of PET bottles such as 5L, 10L, 15L, 20L, and 25L with a holding capacity of up to 0.8 million liter of edible oil per day.

4. Cartoon Factory

It is for packaging low volume (1L-5L) edible oil-filled plastic bottles with 1200/hr carton production capacity. The main process of this factory includes cutting, bending/folding, sealing, and printing, etc.



5. Margarine and Shortening Factory

The shortening and margarine production lines can produce 4 tons/hr equivalent to 100 tons per day production capacity with filling and packaging capacity including under inert atmospheric conditions.



tons/hr of different types of laundry soaps and the toilet soap processing plant with a capacity to produce 1 tons/hr of different type of toilet soaps.

6. Soap Factory

The soap production factory produces soap noodles, different types of laundry, and toilet soap products which have mainly three processing plants. These are the saponification plant with a capacity to produce 3 tons/hr. of soap noodles; the laundry soap processing plant with a capacity to produce 3



7. Sesame Seed Processing Plant

The sesame products processing industry is involved in the production of different types of products which include the following:

- 1 Sesame Cleaning Plant: Process three types of cleaned products, namely:
 - 1.1 Cleaned Sesame with a capacity of 21 tons per hour,
 - 1.2 High-cleaned/premium sesame plant with a capacity of 5 tons per hour, and
 - 1.3 Super cleaned/super premium sesame plant with a capacity of 3 tons per hour.
2. Hulled Sesame Processing Plant with a capacity of 2 tons per hour
3. Roasted Hulled Sesame Processing Plant with a capacity of 1 ton per hour.
4. Tahini Processing Plant with a capacity of 1 ton per hour.



8. Phibela PP Bags Factory

The PP bags factory was acquired in May 2022 and has since been engaged in producing high-quality PP bags for export packaging of sesame seeds and soap noodles. The factory has a capacity of producing 40,000 pp bags per day



9. PhiBela Oil Seeds Crushing Plant

As part of its strategic approach, Phibela began edible oil production by importing, refining and packaging crude oil until enough yield of oil seeds crop is available at local market and from local farmers. In relation to this now sufficient yield of oil seeds, mainly soybean is becoming available locally; as a result, Phibela has erected 500tons per day crude oil extraction and soy protein cake production facility as its first phase of import substitution and enhance export item production strategy. The factory is equipped with unique and state of the

art machineries, is aimed at fulfilling 15% import substitution and export of about 114,000 tons of soy cake per annum.



10. PhiBela Transport

Phibela owns 160 units of brand new IVECO trucks with steam circulation lines and a double tanker. Each of the trucks has a holding capacity of 45,000 liters of edible oil, with a total minimum capacity of 7.2 million liters of edible oil, and dedicated transport of imported RPD palm oil and crude soybean and vegetable oil from the port of neighboring countries' port to the refinery. This enables the company for an uninterrupted supply of raw materials for its operations.



4 BK Metal Engineering Complex (BKMEC)



BKMEC is one of Ethiopia's most renowned and most successful businesses. It also specializes in assembling mini-busses, buses, buses,

trucks, automobiles, and manufacturing trailers and bodies of vehicles. The plant assembles and manufactures different products in its two sites.



This manufacturing firm started its operation in 2019, at sheger city, Gelan sub city, Oromia National Regional State, in the area of 23,000m² with a total investment cost of ETB 2.5 Billion. Currently, Belayneh Kindie Metal Engineering Complex (BKMEC) are manufacturing trailers and semi-trailers; and assembling heavy-duty Iveco trucks and luxury Golden Dragon electric mini buses. In June 2023 BK metal engineering started assembling electric mini Buses and available to the market.



5. Debre Birhan Car Assembly Plant

This car assembly plant was established in Debre Birhan City, Amhara Region. The plant began its operation in 2023. The project cost of the plant was ETB 3 billion. It can assemble heavy-duty trucks, mid-buses, minibuses, and automobiles. It is the first vehicle assembly plant established out of Addis Ababa, and, administered by Phibela Industrial PLC. The assembling plant has its own unique painting house. Debre Birhan Car Assembly Plant has a capacity of manufacturing dry cargo bodies with trailers 2 units /day, fuel tanker trucks with trailers 1 unit/day, minibus assembly 4 units /day, and luxury bus assembly 2 units /day. Now start with 40% of the design capacity manufacturing of dry cargo body with trailers 1 unit/day, minibus assembly 2 units/day, luxury bus assembly 1 unit/day



This assembly has 4 painting booths and those painting houses process all the painting stages within short hours and good quality coating for different vehicle core products. It allows to deliver cars to customers by shortening the long day painting time into hours.

From 2023, this car assembly was starting assembling of Ethiopia's first electric minibuses, city buses, and intercity buses.



BK PP Bags Factory



The PP bag factory was acquired in November 2017 and has since been engaged in producing high-quality PP bags for export packaging. The factory is located in Akaki Kaliti Sub-city, Addis Ababa. Its production capacity is 40 thousand pp bags per day.



4. TRANSPORT SERVICE SECTOR

BK Freight and Fuel Transport Service



This sector was established in 2006 to provide integrated cargo transport service for its affiliate import-export company. The transport service widened its scope of operation and the fuel cargo service was added to the portfolio. The cargo transport service has 36 cross-country cargo truckers and 57 fuel cargo trucker's total of 93 heavy duty trucks. Each dry cargo has a capacity of loading 40 tons and each fuel cargo has a capacity of loading 45 thousand liters of fuel.



Golden Bus Public Transport S.C



Golden Bus S.C. was established in 2017 to provide services for middle-income society with 20 luxury buses. The intercity buses are manufactured by Chinese-based Golden Dragon Bus Ltd. Mr. Belayneh is the sole distributor of Golden Dragon buses in Ethiopia. The company

is the sole after-sales service provider of Golden Dragon Buses and Electric mini buses, mid-buses, and city buses. It also sells fast EV chargers and spare parts for customers.



VELOCITY EXPRESS S.C

Besides importing and assembling EVs, for sale in the market, the BKG has established a public transport service company called Velocity Express s.c in 2024. In addition to assembling cars, BKG has become the first company to launch electric powered minibuses and city buses which are used to public transport service in Addis Ababa. The main objective for the establishment of velocity is to serve as a model for transport companies in Ethiopia. The PLC is also introducing digital payment for passengers.



5. CONSTRUCTION SECTOR

Belayneh Kindie General Contractor (BKGC)



The construction sector is one of the sectors that Belayneh Kindie Group (BKGC) is engaged in.

The Sector was established in the year 2011. The construction business line was initially engaged in providing machinery rental services for customers by owning bulldozers, excavators, graders, dump trucks, and concrete mixers.

BK General Contractor currently has a Grade One General Contractor and engaged in construction projects from light to large scale.



BK Grade One General Contractor started its business by building BKG projects.

Since From 2023 BKGC has been participating in the success of national mega projects beyond BKG projects. As an example, Dine for Generations of Haik Resort project in Amhara region and Kurmuk Gold mine project in Benishangul region.

Currently, BKGC is being organized at a high level in terms of human resources and materials, and is working hard to become the preferred construction company in the country in the coming years.

Piassa Plaza

The twine 27-storey building is to be built in the center of the piazza by Belayneh Kinde Group. The building has a total area of 9,000 square meters and the building comprises commercial areas and apartments. The completion of the building is another milestone for Belayneh Kinde Group and the Piazza area. it will cost 20 billion birr to complete the construction of the building. The design work and the land excavation work were undergoing.



BKTM CONCRETE POLE PRODUCTION

Mr Belayineh Kindie & Tadess Mihretie have established two concrete pole manufacturing plants in Bahir Dar and Gondar cities with a capital of ETB 60,000,000 million in 2018. Now the plants have total assets of ETB 600,000,000 million.



Each manufacturing plant can produce 100 poles per Day. In addition to the pole factory, there are having two stone crushing plants at each factory of capacity 200TPH. The crushing plant supplies raw material (crushed stone for the pole factory) and then to the local users.

6. HOTELS SERVICE SECTOR

BK was engaged in the hotel business by acquiring Ethiopia Hotel and Adama Ras Hotel in 2009 from the Ethiopian Privatization Agency. The hotels were secured by winning a government auction with an aggregate investment capital of ETB 134 million.

Ethiopia Hotel No 1



Ethiopia Hotel is located in the center of Addis Ababa. It was established in 1963 to host the participants of the former Organization of African Unity (OAU) during its formation. The hotel has 110 rooms and currently, the owner of the hotel has the plan to redevelop a new high-rise mixed-use building with 46 and 26-story buildings accommodating a five-star hotel, retail shops, offices, and apartments.



A new design of Ethiopia Hotel

Adama Ras Hotel

This is another hotel located in Adama City Oromia Regional State, 100 km south of Addis Ababa. It was founded in 1960, during the reign of Emperor Haile Selassie. Currently, the hotel has 68 rooms. After the acquisition of the Ethiopian Privatization Agency, various development activities have been made to improve its standards.





An expansion project is ongoing and it has reached its finishing phase to upgrade the standard of this hotel to a four-star level.

Ethiopia Hotel No. 2

Ethiopia Hotel has rented the former Global Hotel, a four-star establishment to expand its service. A five-year contract has been signed and work has begun on the official takeover of the hotel. . It has about 50 state-of-the-art bedrooms and various-sized halls with a capacity of 10 to 2,000 people.



Bahirdar Hilton Resort and Spa



Hilton Bahir Dar Hotel and Spa is situated along the Blue Nile River, next to the Bahir Dar Convention Center. The hotel has an iconic structure, symbolizing the emerging strength of the city. It is designed to create a new world-class luxury destination for travelers to Bahir Dar.



The building occupies a plot of land measuring 41,422 square meters and includes a total of 191 guest rooms. This innovative hotel project is currently under construction in Bahir Dar city. It is planned to finalize the project without delay and its opening is expected to take place in the coming few years.



BKG Foundation



BKG strives to remain a business that is regarded as trustworthy and reliable by the society. To that end, it has been working to support different social activities in different regions of the country.



For many years BKG has been supporting communities in the areas of health, education, infrastructure development, construction, environmental protection, feeding, and sports. However, its support has been implemented in a scattered manner over the past years. In the year 2021, the BKG Foundation was officially registered.



It is led by Mrs. Adanech Kefale, the spouse and business partner of Mr. Belayneh Kindie. BKG Foundation has been bestowed with various tasks in shouldering out its various corporate responsibilities, especially in the last five years. From /2018-2024/ BKG has spent more than **ETB 900 million** and fulfilled its social responsibilities. Some of the donations and philanthropic activities provided by the BKG are listed below:

1. BKG Purchased Bond amounting to **ETB 36 million** for the construction of the GERD
2. BKG donated ETB 80 million for the “Gebeta Lehager Gebeta Lesheger Gebeta letewold ” beautification projects .

3. BKG provided **ETB 28 million** to the rehabilitation efforts of Oromia, Amhara, and Somali Regional governments for internally displaced citizens
4. BKG provided **ETB 10 million** to the West Gojam Zone Administration to serve as a revolving fund for job creation endeavors for the youth.
5. BKG has built a feeding center in Addis Ababa city that can accommodate one meal for up to 500 people per day. The center was constructed at a cost of more than **ETB 15 million**. The annual budget of the feeding center is **ETB 7 million**.

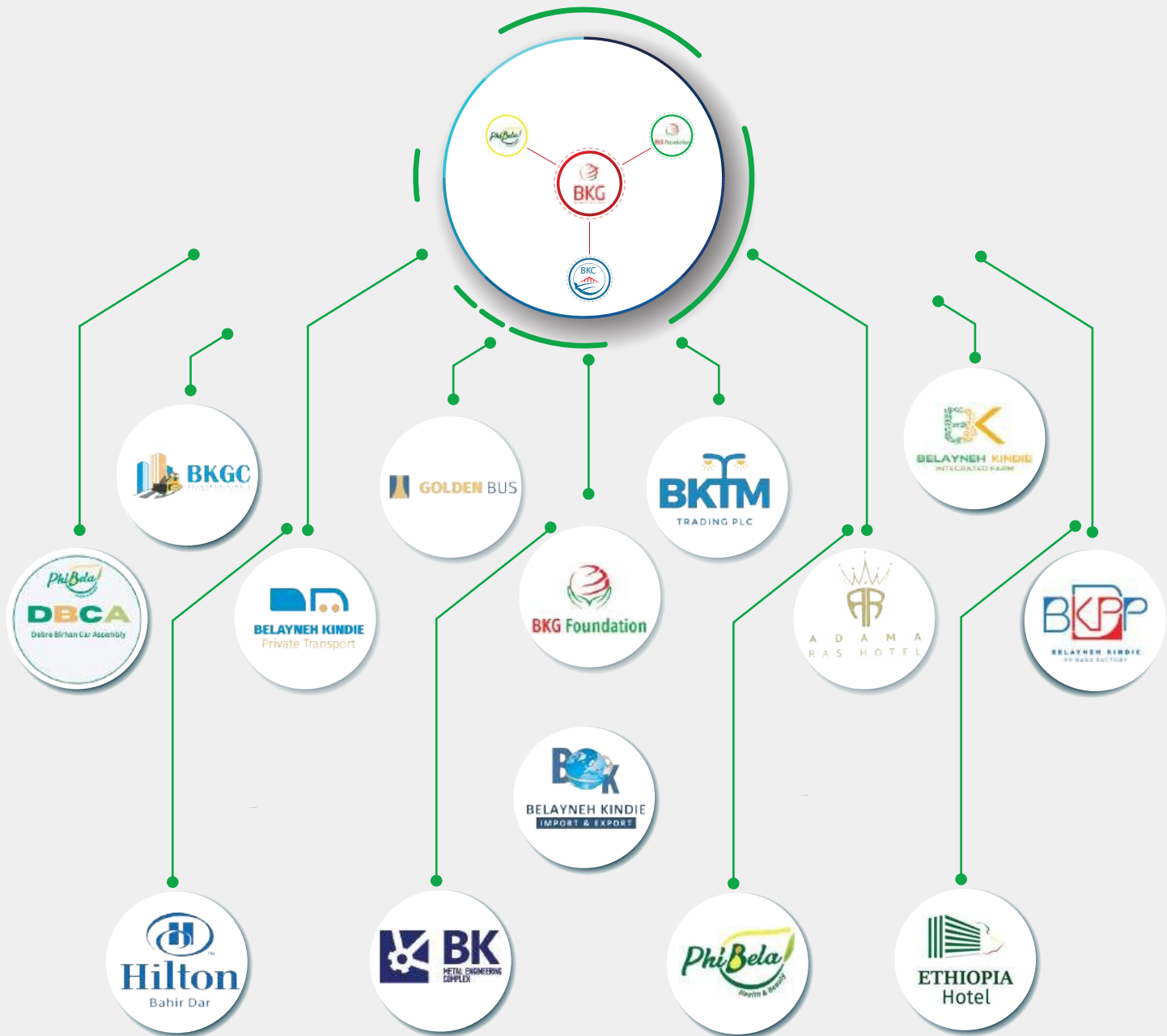

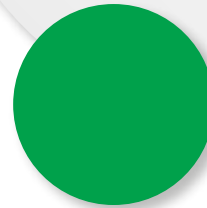
